**NOTE TO CALIFORNIA CUSTOMERS:** (1) This form is for product registration; (2) Failure to complete and return the registration form does not diminish your rights under this limited warranty. **ALL OTHER CUSTOMERS:** This registration form must be completed and returned within 45 days of the application of DuPont™ Automotive Protection Package in order to obtain coverage under this limited warranty. Your warranty period begins on the date the DuPont™ Automotive Protection Package is applied to the vehicle.

**DEFINITIONS:** (1) DuPont™ Automotive Protection Package, DuPont™ Exterior Protection and DuPont™ Interior Protection are the products referred to in this limited product warranty. (2) Advantage Product Pipeline, LLC ("We, Us, Our") is the warrantor and administrator of this DuPont™ Automotive Protection Package limited warranty. (3) The Dealership listed above is the seller of the DuPont™ Automotive Protection Package (4) The Consumer is you, the Vehicle Owner(s) listed above.

**WARRANTY TERMS:** Advantage Product Pipeline, LLC hereby warrants to the above named Vehicle Owner that any and all portions of a New or Pre-Owned vehicle treated with the DuPont™ Automotive Protection Package are covered against damage arising due to a failure of the Interior Protection or Exterior Protection performing as warranted as described in the *Vehicle Coverage* section below. This limited warranty runs for a period not to exceed seven years beginning with the date the DuPont™ Automotive Protection Package is applied. For New Vehicles Our obligations will include professional reconditioning, repair, or replacement of a treated surface as described in the *Repair Obligations* section below. For Pre-Owned Vehicles Our obligations are limited to professional reconditioning and repair only as described in the *Repair Obligations* section below. This limited warranty is transferable to one subsequent owner if not expired at no additional cost for the remainder of the term of the original warranty. Our obligations under a transferred limited warranty are limited to professional reconditioning as described in the *Repair Obligations* section below. To transfer this limited warranty please call DuPont Customer Care at 1-888-227-3093.

**ELIGIBILITY:** New vehicles are classified as previously untitled vehicles with no mileage limitations. Pre-Owned Vehicles are classified as any vehicle that has been previously titled with no mileage limitations. RVs, Conversion Vans and Commercial Vehicles are not eligible for this limited warranty. Please inquire with your dealer about options available for these types of vehicles.

**VEHICLE COVERAGE:**

**INTERIOR:** Advantage Product Pipeline, LLC warrants any and all factory installed interior surfaces and factory floor mats treated with DuPont™ Interior Protection against stains resulting from items such as: spills of food or drink normally consumed in a vehicle, pet or human bodily fluids, nail polish, cosmetics, lotions, crayons, oil, grease and gum. Treated interior surfaces will be warranted against fading, discoloration, or cracking caused by exposure to high temperatures. Advantage Product Pipeline, LLC reserves the right to attempt to remedy any such damages by means of professional reconditioning prior to repairing or replacing any surface.

**EXTERIOR:** Advantage Product Pipeline, LLC warrants any and all factory painted exterior surfaces treated with DuPont™ Exterior Protection against staining, fading, oxidation, or loss of gloss caused by exposure to elements such as weather induced acid rain, water spotting, road and sea salts, dust, insects, bird droppings and tree sap. Damage to factory painted exterior surfaces treated with DuPont™ Exterior Protection due to airborne paint and road tar is covered under this limited warranty unless covered under an insurance policy or by a third party responsible for the damage. Also covered are damage to alloy wheels treated with DuPont™ Exterior Protection due to brake dust penetration and the exterior of headlights treated with DuPont™ Exterior Protection due to yellowing or clouding. Advantage Product Pipeline, LLC reserves the right to attempt to remedy damage by means of professional reconditioning prior to repairing or repainting any surface.

**COVERAGE LIMITATIONS:** This limited warranty does not cover surfaces with damage that existed prior to the application of DuPont™ Automotive Protection Package or surfaces that are not treatable by DuPont™ Automotive Protection Package (including, but not limited to non glossy paints, steering wheels, foot pedals, seat belts, rawhide leather, etc.) or untreated, repaired or repainted surfaces, or damage resulting from paint defects as deemed by the manufacturer's written notices, or any parts assembled or installed after vehicle left the factory. This limited warranty will not apply to damage caused by normal wear and tear that is not expressly included in the *Vehicle Coverage* section above, theft, vandalism, fire, natural catastrophe, collision, road hazards, objects striking vehicle, rust or surface rust, chipping, flaking, cracking or separating paint, rips, tears, burns, or punctures, failure of the vehicle owner to exercise reasonable care, or any damage resulting from intentional acts of the vehicle owner or misuse or abuse of the vehicle. This limited warranty does not cover damage caused by corrosive materials such as acids and bleach. Additionally, this limited warranty does not cover damage to headliners. If a stain is caused by dyes or ink, the remedy under this limited warranty is limited to a cleaning and professional re-dyeing of affected area. If the exterior of treated headlights cloud or yellow the remedy under this limited warranty is limited to professional reconditioning only. This limited warranty further excludes damages that are a result of vehicle manufacturer's defects; modification or alteration of the original manufacturer's finish, or equipment; or any alteration to the factory-installed interior. In addition, any damage to the truck bed floor panel, side panels or tailgate panel that faces the inside of the bed is excluded. Convertible tops are not covered by this limited warranty. Advantage Product Pipeline, LLC reserves the right to inspect your vehicle regarding any of the above types of acts, conditions, or conduct. Should Advantage Product Pipeline, LLC discover that your vehicle's defect is due to any of the above acts, conditions, or conduct, this limited warranty will be void at the discretion of Advantage Product Pipeline, LLC. Advantage Product Pipeline, LLC is not responsible for any shipment, travel, or other costs involved with the inspection or repair of your vehicle or damages arising therefrom.

**REGISTRATION:** Except California residents, the registration of this limited warranty must be submitted by completing the above registration form, and forwarding the white copy of this document to Advantage Product Pipeline, LLC, Attention: Limited Warranty Registration Department, 8509 Sunstate St. Suite 200, Tampa, FL 33634 within 45 days after the application of DuPont™ Automotive Protection Package. **FAILURE TO COMPLETE AND RETURN THE ABOVE REGISTRATION FORM WILL VOID THIS LIMITED WARRANTY.**

**OWNER REQUIREMENTS:** Vehicle owner should maintain the vehicle by frequent vacuuming of interior carpet and upholstery, regular washing and waxing of the exterior of the vehicle and by removing any spills or items that could cause permanent damage. It is strongly recommended to follow the procedures for care and maintenance as outlined in the DuPont™ Automotive Protection Package, Care and Maintenance brochure. Failure to report any damage to vehicle within 60 days of the occurrence will relieve Advantage Product Pipeline, LLC from any and all legal responsibility described under this limited warranty.

**CLAIMS PROCEDURES:** In order to be valid, a claim in connection with a registered limited warranty must be submitted in writing during the warranty period. A claim must also be submitted within 60 days of occurrence or observation of damage. Claims can be submitted by contacting DuPont Customer Care at **1-888-227-3093**, by visiting [www.autoprotection.dupont.com](http://www.autoprotection.dupont.com) or by sending a written description of damage along with contact information and warranty # or VIN to Advantage Product Pipeline, LLC, Attention: Limited Warranty Claims Department, 8509 Sunstate St. Suite 200, Tampa, FL 33634. It is not necessary to send a copy of this limited warranty with your claim unless proof of purchase needs validation. Advantage Product Pipeline, LLC reserves the right to request additional information from the vehicle owner. Failure to follow these procedures will relieve Advantage Product Pipeline, LLC of any and all legal responsibilities with regard to this limited warranty.

**REPAIR OBLIGATIONS:** Advantage Product Pipeline, LLC has the sole discretion in the implementation of repair procedures in accordance with the terms of this limited warranty. Liability assumed by Advantage Product Pipeline, LLC shall be limited to the cost of repair, not to exceed the current NADA Trade In value of the vehicle. In the event the cost of the repairs exceed the current NADA Trade In value of the vehicle, the amount of the current NADA Trade In value will be paid to the vehicle owner and this limited warranty will terminate. If damage covered by this limited warranty results in the loss of use of the vehicle for four (4) or more hours due to labor repair time, We will reimburse you for a rental car up to \$35 per day for a maximum of five days. Any rental car reimbursement benefits must be pre-authorized by Us prior to rental. We will not reimburse you for rental expenses incurred on a Saturday or Sunday.

**LEGAL RIGHTS NOTICE:** THIS LIMITED WARRANTY SETS OUT THE FULL EXTENT OF OUR RESPONSIBILITIES, AND THE EXCLUSIVE REMEDY REGARDING THE DUPONT™AUTOMOTIVE PROTECTION PACKAGE. ALL IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION, IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED TO THE DURATION OF THIS LIMITED WARRANTY. ADVANTAGE PRODUCT PIPELINE, LLC SHALL NOT BE LIABLE FOR SPECIAL, INDIRECT, INCIDENTAL, PUNITIVE OR CONSEQUENTIAL DAMAGES (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, EXPENSES ARISING OUT OF THIRD PARTY CLAIMS, LOSS OF USE OF THE VEHICLE, INCONVENIENCE, OR ANY OTHER LOSS), WHETHER OR NOT CAUSED BY OR RESULTING FROM BREACH OF CONTRACT, NEGLIGENCE, OR OTHER WRONGFUL ACT OR OMISSION, EVEN IF IT HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. ADVANTAGE PRODUCT PIPELINE, LLC DOES NOT AUTHORIZE ANY PERSON, ENTITY OR FACILITY TO CREATE FOR IT ANY OTHER WARRANTY OBLIGATION OR LIABILITY IN CONNECTION WITH THIS PRODUCT. In addition, some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you.
